RULES & REGULATIONS

1. SUBLETTING OF SPACE

No exhibitor shall exhibit or permit to be exhibited in the space allotted to him, any merchandise other than that specified in the Application. The space shall not be sublet without the written consent of The MegaSpeed Custom Car & Truck Show and the sharing of space by the Exhibitor or use of space by persons or in a manner not authorized by The MegaSpeed Custom Car & Truck Show is prohibited.

2. USE OF AISLES, ETC.

Any and all advertising distribution must be made from the Exhibitor's booth space only. Uniformed attendants, models and other employees must remain in the booths occupied by their employers. The aisles, passageways and overhead spaces remain strictly under control of the Show and no signs, decorations, banners, advertising matter or special exhibits will be permitted in them except by special permission of The MegaSpeed Custom Car & Truck Show. All exhibits must remain within the confines of their own space and no Exhibitor will be permitted to erect signs or display products in such a manner as to obstruct the view, occasion injury or disadvantageously affect the display of other exhibitors.

3. SOUND AND VIDEO

Exhibitors operating video, sound equipment, stereos, PA systems or any other noise generating devices shall do so only at a level that will not interfere with other exhibitors or add congestion to the aisles of the show.

4. CARE OF THE SPACES

The Exhibitor shall arrange for sweeping and cleaning of the space and must at his own expense, keep any spaces utilized for the event suitably arranged, dusted and in good order. Exhibitor attendants must remove waste material from the building and lands at the expense of the Exhibitor. The Exhibitor will leave the space in clean condition and good repair, reasonable wear and tear and damage by fire, lightning and tempest only excepted.

5. LIABILITY AND DAMAGE TO BUILDING

If the lands or any portion of the building or any equipment contained therein during the term of this licence shall be damaged by the act, default or negligence of the Exhibitor, his agents or his employees, the Exhibitor shall pay to The MegaSpeed Custom Car & Truck Show upon demand such sum as shall be necessary to restore the lands and building or equipment contained therein to their condition as at the start of the event. Nothing shall be tacked, nailed, screwed or otherwise attached to drapes, columns, walls, floors or other parts of the building.

6. RESPONSIBILITY OF EXHIBITOR

As well as to all products and / or services offered or sold by the Exhibitor. Wherever an obligation is imposed upon the Exhibitor hereunder, such obligation shall extend to all agents, officers, employees, and others for whom the Exhibitor is at law responsible and the Exhibitor shall indemnify and save The MegaSpeed Custom Car & Truck Show harmless from any violation or breach of this agreement by such agents, officers, employees, exhibitors and others. The Exhibitor hereby assumes full responsibility for the character, acts and conduct of all persons employed by the Exhibitor.

7. INSURANCE

Exhibitor's property shall be placed on display and exhibited at his own risk and neither The MegaSpeed Custom Car & Truck Show, its agents or employees shall be deemed to assume any responsibility therefore; nor shall The MegaSpeed Custom Car & Truck Show its agents or employees be accountable for the death or injury to any person or for damage or loss of property of the Exhibitor, its officers, agents, employees or invitees resulting from any cause whatsoever and the Exhibitor shall indemnify and hold them harmless from any suit or claim arising out of any action or failure to act by the Exhibitor; and the Exhibitor shall secure and furnish upon demand, evidence of comprehensive general liability insurance coverage adequate therefore. Watchmen will be on duty day and night, but the Show, while taking all precautions against loss, will not guarantee against it. Exhibitors wishing to insure their goods must do so at their own expense.

8. NO INFLAMMABLE MATERIAL

No gasoline, acetylene, polish, glue, explosives or inflammable material will be allowed in any part of the building, and no goods or materials that conflict with the rules of the local Fire Department or any relevant governmental authority may be exhibited or brought into the building.

9. MOVING OUT

Failure to remove an exhibit in the allotted time will afford The MegaSpeed Custom Car & Truck Show the right to remove and place same in a warehouse, subject to the Exhibitor's disposition, with all charges to follow and no liability to the Show. All exhibits must remain intact until the Show officially is closed. All parts of the event including any exhibit must be entirely removed from the building by 11:59 P.M. Sunday.

10. FIRE AND DESTRUCTION OF SPACE

In the event that the building or any part thereof shall be destroyed or damaged by fire or other cause so as to prevent the use of the space for the purpose hereof, or if the space cannot be used because of strikes, riots, labour controversies, accidents, fuel shortages, acts of God or the Queen's enemies, forces majeure or other causes beyond The MegaSpeed Custom Car & Truck Show's care and control, then this licence shall terminate and The MegaSpeed Custom Car & Truck Show shall have no liability toward the Exhibitor by reason of its failure to deliver leased space.

11. RIGHT OF ENTRY

The MegaSpeed Custom Car & Truck Show reserves the right through its representatives to enter any portion of the space and to eject any objectionable person or persons from the space and from the lands and premises and upon the exercise of this authority, the Exhibitor hereby waives any right and all claims for damages against The MegaSpeed Custom Car & Truck Show. The MegaSpeed Custom Car & Truck Show reserves the right, without recourse by the Exhibitor for any loss or damage incurred, to refuse admission to, remove or prohibit in the space and/or the building exhibitors, exhibition personnel, members of the public, exhibits, printed matter, souvenirs or novelties which may in The MegaSpeed Custom Car & Truck Show's sole opinion, be objectionable or offensive.

12. CONCESSIONS

The MegaSpeed Custom Car & Truck Show specifically reserves any and all concessions in the building including checkroom, food, alcoholic beverages and sundries of any nature whatsoever, and the Exhibitor agrees that none of the aforementioned items shall be sold by the Exhibitor or from the space without the prior written permission of The MegaSpeed Custom Car & Truck Show.

13. COMPLIANCE WITH LAWS

The Exhibitor will comply with all applicable federal, provincial and municipal laws, rules and regulations, and all rules and requirements of the local Police and Fire Departments or other municipal authorities, and will obtain and pay for all necessary permits and licences.

14. FAILURE TO TAKE POSSESSION

If the Exhibitor, being entitled to possession hereunder shall fail for any reason to take possession of or to use the space, no refund shall be made and the full compensation called for by this licence, including any disbursements or expense incurred by The MegaSpeed Custom Car & Truck Show in connection therewith, shall be payable by the Exhibitor to The MegaSpeed Custom Car & Truck Show as liquidated damages, and not by way of penalty.

15. ADDITIONAL RULES AND REGULATIONS

The MegaSpeed Custom Car & Truck Show may issue additional rules and regulations, which additional rules and regulation shall be binding upon the Exhibitors.
